**A. CALL TO ORDER**

**FIRST ORDER OF BUSINESS**

Roll Call. Public notice of this meeting has been given, and a quorum is present.

**1. Discussion and possible action to approve ordinance regarding possible industrial manufacturing.**

After discussion, Alderman Terry Cole made a motion that no new industrial manufacturing shall be allowed within the city limits of Winona, it was seconded by Alderman Luis Diaz. All in favor, none opposed, Motion carried unanimously.

**2. Discussion and possible action to approve ordinance regarding junk yards.**

After discussion, Alderman Gary Fox made a motion to approve no junk yards within the city limits of Winona and to follow state regulations outside city limits, and it was seconded by, Mayor Pro-Tem Dee Roden. All in favor, none opposed, Motion carried unanimously.

**3. Discussion and possible action to approve ordinance regarding game rooms, slot machines, or gambling.**

After discussion, Mayor Pro-Tem Dee Roden made a motion to prohibit game rooms, slot machines, or any type of gambling involving money or sweepstakes, legal or illegal, following or

exceeding Smith County ordinances on the matter within the city limits of Winona, and it was seconded by Alderman Shanna Clark. All in favor, none opposed, Motion carried unanimously.

- 4. Discussion and possible action to approve ordinance on bars/clubs** After discussion, Alderman Terry Cole made a motion to ban alcohol after hours, including but not limited to pubs, bars, dance clubs, strip clubs, or any establishment that generates more than 51% of its income from the sale of alcohol, as defined by the TABC, and it was seconded by Mayor Pro-Tem Dee Roden. All in favor, none opposed, Motion carried unanimously.

**E. ADJOURNMENT**

Alderman Terry Cole made the motion to adjourn this meeting at 07:04 pm, and Mayor Pro-Tem Dee Roden seconded. All in favor, none opposed, Motion carried unanimously.
